Tuition Information

Boys to Men is a non-profit 501(3)c corporation. However, we do need money to put on Passage Adventure Weekends, activities, and manage the mentorship program. We must charge a nominal fee. If you are unable to pay the full amount we will find some other way for you to help. No boy will be turned down for lack of money.

TUITION: \$600 COVERS COMPLETE weekend "Rites Of Passage" Adventure, including room and board, plus one year of ongoing Mentorship activities (usually every other weekend with all the boys and group mentoring). There will be a few optional events like camp outs for which BTM will ask a nominal participation fee.

DEPOSIT: \$100 (non-refundable) reserves a boy's space.

Payment plans and some scholarships are available.

Refund/Cancellation Policy

1. If you cancel your agreement to attend the Weekend "Rites Of Passage" Adventure more than one week before the Weekend Date, your tuition will be refunded, less a 25.00 processing fee.
2. If you cancel your agreement to attend the Weekend "Rites Of Passage" Adventure less than one week before the Weekend Date, your tuition will be refunded, less the \$100 deposit.
3. If after the Weekend "Rites of Passage" Adventure, you are not satisfied with the experience, your tuition will be refunded, less the \$100 deposit, if you have met all the following conditions:
 - a) Tuition has been paid in full, payment plan arrangements have been made and agreed upon prior to the Weekend Adventure.
 - b) The boy has been in attendance the full time for each of the three days of the Weekend Adventure.
 - c) The boy has participated in all of the exercises in the Weekend Adventure.
 - d) The boy or the guardian has submitted a written request for a refund, stating the reasons for your dissatisfaction, within 7 days after completing the Weekend Adventure.
 - e) The boy or guardian has met with a Boys To Men Mentoring Network representative for a clearing session.
